

Steps to Become an Affiliated Provider

To become a community service provider to individuals with intellectual and/or developmental disabilities (IDD) in Cherokee, Crawford, Labette and/or Montgomery Counties, affiliation with the CDDO of Southeast Kansas is required. There are several steps to becoming an affiliated provider.

License

The first step is to obtain a license from the Kansas Department on Aging and Disability Services (KDADS) <u>Department for Aging and Disability Services | Home</u> if affiliate plans to provide one or more of the following services.

- Day Supports
- Residential Supports
- Targeted Case Management

KDADS reserves the right to modify the list of services that require a license.

Affiliation

The Application for Affiliation can be found on our website https://cddosek.org. In addition to the completion of the application, the following list of documents must be submitted.

- Copies of applicable license(s)
- Certificate of liability insurance naming the CDDO as additional insured
- Organizational Chart
- KMAP Provider Number, see below
- ➤ If provider is affiliated with another CDDO(s) in Kansas, submit a letter of good standing from the other CDDO(s)

Kansas Medical Assistance Program (KMAP)

Payment for IDD services is from the Kansas Home and Community Based Services (HCBS) Medicaid Waiver. To bill Medicaid, providers must register with KMAP to obtain a Medicaid Provider number. FAQ This link will take you to KMAP FAQ where it explains steps to submit an application to KMAP.

HCBS Settings Final Rule

Certain providers will have to establish compliance with the HCBS Settings Final Rule prior to completing the enrollment process through KMAP. This is accomplished by registering with the HCBS Compliance Portal and obtaining a verification letter that must be submitted during KMAP enrollment and re-enrollment. In addition to registering with the HCBS Compliance Portal, Final Rule Assessments must be completed for each provider owned,

controlled, and managed setting depending on how services are provided. Annual Final Rule Setting Compliance Certifications for each location are required to bill HCBS. <u>KDADS</u> HCBS Final Rule - User Manuals

Managed Care Organizations

Kansas Medicaid (KanCare) services are managed by three Managed Care Organizations (MCO); Healthy Blue, Sunflower and United. Each person served has selected an MCO. Providers must contract with one or more MCOs to receive referrals for individuals covered by that MCO. You can find additional information at each MCOs website.
